نقسب پنجاب کو تیل گورنمنٹ

مقدمہ: بالا میں نقسب پنجاب کے منظور کردہ تیل تحقیق ایجنسی کی اہل معین مدت میں قبیل اضروری کارروائی کے لئے اس کے ساتھ منسلک ہے۔

مما و صراحتی سے یاد رکھنا کہ

1- The Punjab Office of the Ombudsman Act 1997 کی دفعہ 11 کی ذیلی سشن 2 کے تحت ایجنسی معترضہ مدت میں ایجنسی کو تیل کرنے یا عدم قبیل کی وجہ سے نقسب کو مطلع کرنے کی پابندی ہے۔

2- مقدمہ بالا قانون کی دفعہ 32 کے تحت نقسب پنجاب کے کسی حکم یا ایجنسی سے متاثرہ شخص 30 یوم کے اندر اپنی عرضداشت گورنر پنجاب کو تیل کر سکتا ہے۔ جو اپنی صوابدہ پے کے مطابق اس پر مناسب حکم جاری کرنے کے تیار ہیں۔ عرضداشت کے ساتھ مقدمہ جیل دستاویز اسٹیشن منسلک کرنا لازمی ہے۔

(الف) کہیں پورا تیل و ششماقی کارروائی کا تیل۔

(ب) نقسب کے ایجنسی کی اہل معترضہ کی کارروائی جس کے ذریعے ایجنسی ارسال کیا گیا ہو۔

(ج) حلیہ جان کہ عرضداشت میں جو پر شک کے متعلقہ جہات درخواست گزار کی مطلوبہ مدت کی حد تک درست ہیں اور درخواست کے موضوع پر شک کے حوالے سے کوئی ایجنسی عدالت میں ذمہ سہمت نہیں ہے نہ ہی کسی عدالت نے اس کے بارے میں کوئی حکم ایجنسی دیا ہے۔

3- اگر تیل تحقیق ایجنسی میں درج تیل پر مذکورہ بالا سیشن (1) کے مطابق قبیل نہیں کر سکتی تو ایجنسی ان وجوہ سے جن کی پہلادہ قبیل نہیں کی گئی ایجنسی پر قبیل اس فرض سے کسی نامزد اس کے دستخطوں سے نقسب کو مطلع کرے گی نامزد اس کے دستخطوں سے مطلع کرنے کی صورت میں ایجنسی ایجنسی پر قبیل اس سے منظور کی گئی اور اس امر کی مراعیت اطلاع نامہ میں کی جائے گی۔

## ORDER

**Subject:** DEMAND FOR BS-16 TO STENOGRAPHER (BS-15 SELECTION GRADE AND BASIC SCALE BS-12) ON THE ANALOGY OF SENIOR SCALE STENOGRAPHER (BS-15) WHO WERE GRANTED UPGRADED BS-16 W.E.F. 23.12.2011 VIDE THE FINANCE DEPARTMENT CIRCULAR DATED 12.02.2013.


### COMPLAINT

Mr. Shaukat Ali Wattoo s/o Nazir Ahmad Wattoo and five other, all Stenographer (BS-15 Selection Grade and Basic Scale BS-12), office of the Director General, Public Relations, Punjab, Lahore stated that the Senior Scale Stenographer (BS-15) were granted upgraded BS-16 w.e.f. 23.12.2011 vide the Finance Department circular dated 12.02.2013, but the complainants (six in number) who were basically Stenographer in BS-12 and were granted BS-15 by virtue of selection grade were not treated at par with those of the Senior Scale Stenographer (Basic Scale of Pay i.e. BS-15) who were upgraded to BS-16, vide the Finance Department circular dated 12.02.2013. They seek a direction to the Finance Department to include them (Stenographer BS-12 who got selection grade BS-15) with the Senior Scale Stenographers (BS-15), who were upgraded to BS-16. In other words, the complainant claimed the cadre posts of (i) Stenographer (BS-15 selection grade with Basic Scale BS-12) and (ii) Senior Scale Stenographer (BS-15 Basic Scale of post) one and the same for the purpose of grant of upgradation to BS-16.

### REPORT OF THE AGENCY

2. Despite issuance of notices, the S&GAD and Finance Department did not submit parawise comments.

3. Compliance report dated Nil, submitted by the O/o D.G. Public Relations, Punjab, Lahore and the Information, Culture and Youth Affairs Department, Punjab was not going to serve the purpose being restrictive to only one point while for the other three points, raised in the complaint, the report declared them as not related to DGPR and IC&YA Departments.

4. Being the matter amply clear, the procedure laid down in Regulations No. 10 and 12 of the Ombudsman for the Province of Punjab (Registration, Investigation and Disposal of Complaints) Regulations, 2005 was relaxed.

#### PROCEEDINGS

5. There are two cadre posts (i) Stenographer (BS-12) and Senior Scale Stenographer (BS-15), and the Finance Department vide circular No.FD.PC.14-38/78 (PF-V), dated 12.02.2013, upgraded the post of Stenographer (BS-12) to BS-14 and Senior Scale Stenographer (BS-15) to BS-16 w.e.f. 23.12.2011, that too, vide para 3 ibid, it was stipulated that there would be no change in pay scales of the incumbents holding selection grades in the capacity of Stenographer, Senior Scale Stenographer / Personal Assistant and Private Secretary. Stenographers who acquired BS-15 by virtue of selection grade neither constitute a separate cadre nor they were given the nomenclature of Senior Scale Stenographer (BS-15) / Personal Assistant. The complainants, even being in selection grade BS-15 fall in the cadre of Stenographer with Basic Scale BS-12.


#### FINDINGS


6. The complainants are the incumbents of the post of Stenographer (Basic Scale BS-12), which was upgraded to BS-14, hence, in term of Para 3 of the Finance Department circular, there would be no change in BS-15, acquired by the complainants by virtue of selection grade, prior to upgradation of the post of Stenographer to BS-14 w.e.f. 23.12.2011. The scheme of selection grade had already been abolished w.e.f. 01.12.2001 in the RBPS-2001.

7. The reference of Government of Sindh, Finance Department circular dated 21.03.2013 was relevant to the same situation although pertaining to other province.

8. The complaint is recommended for consideration by the S&GAD (Regulations Wing) / Finance Department / D.G. P.R. Punjab decision of the Punjab Government on the lines of Sind Government and report compliance to the office within one month from the issue of this order as required under section 11(2) of the Punjab O/o Ombudsman Act, 1997.

9. The complaint is disposed of in these terms. Parties be informed.
