- On a proposal received from Pakistan Computer Bureau under Ministry of Information Technology, Secretary Establishment has been pleased to approve 1. as under.
 - The post of Key Punch Operator/Key Punch verifying Operator, where ever existing, may be re-designated as Data Entry Operator.
 - The post of Data Entry Operator may be up-graded from (BPS-10) to (BPS-12) in all Government Departments. In the Ministries/Divisions/Departments (ii) which have the posts of Data Entry Operator in (BPS-14 and 15), the said post may be down graded to (BPS-12) as and when the present incumbents of the posts leave the said posts.
 - The qualification for appointment to the up-graded post of Data Entry (iii) Operator may be prescribed as Bechelor's Degree in Physics/Mathematics/Statistics/Economics with a minimum speed of 10,000 Key depressions per hour for Data Entry, in the Recruitment Rules to be amended/framed with the concurrence of this Division.
 - The proposal at (i) above is under process in the Finance Division.

In view of the above it is requested that this Hon'ble Tribunal may be pleased to dismiss the appeal of the appellant with costs.
