**GRANT OF ADHOC RELIEF ALLOWANCE – 2013 @ 15% OF**  
**BASIC PAY TO THE EMPLOYEES OF THE PROVINCIAL**  
**GOVERNMENT.**

**Dear Sir,**

The Governor, Khyber Pakhtunkhwa, is pleased to sanction, w.e.f **1<sup>st</sup> July, 2013** and until further orders, an **Ad-hoc Relief Allowance – 2013 @ 15%** of basic pay to all the employees of the Provincial Government including contingent paid staff and contract employees, employed against civil posts in basic pay scales on standard terms & conditions of contract appointment.


2. The amount of this Adhoc Relief Allowance - 2013:-
  - i will be subject to Income Tax,
  - ii will be admissible during leave, and entire period of LPR except extra-ordinary leave.
  - iii will not be treated as part of emoluments for the purpose of calculation of pension commutation / gratuity and recovery of House Rent,
  - iv will not be admissible to the employees during the tenure of their posting / deputation abroad,
  - v will be admissible to the employees on their repatriation from posting/deputation abroad at the rate and amount which would have been admissible to them, had they not been posted abroad.

3. The term “**Basic Pay**” for the purpose of Adhoc Relief Allowance – 2013 will also include the amount of personal pay granted on account of annual increment(s) beyond the maximum of the existing pay scales.

4. The above **Adhoc Relief Allowance – 2013** shall be accommodated / met out within the budgetary allocation for the year 2013-14 by the respective departments / organizations, and no supplementary grants would be given on this account.
